The basis for the selection of the offer will be the determined point value of each offer. The Awarding Entity may award the Bidder a maximum of 100 points. The offer with the most points will be considered the most advantageous, i.e. presenting the most advantageous balance of the offer evaluation criteria. The resulting number of points in each criterion will be finally calculated with the second decimal place, observing the following rule: if the thousandth place parameter is below 5, the hundredth parameter is rounded down if the thousandth place parameter is 5 and above is the hundredth parameter rounds up.
